PURCHASE AGREEMENT

I (We) promise to pay my (our) account in full within fifteen (15) days after your statement is received, or as specified in terms and conditions of a separate written contract. If, however, this account is not paid as agreed, a delinquency charge shall accrue on this amount of said unpaid account after thirty (30) days from the date of statement, as follows: the delinquency charge shall be computed at a rate of 18% per annum on the unpaid balance or at the highest rate of interest allowed by applicable law, for loans or forbearance's of money, whichever is less; provided, however, said service charge shall be computed at a rate not less than 12% per annum. I (We) agree to pay, in addition to the foregoing, reasonable attorneys fees incurred in connection with the collection of this account, or if this account is placed in the hands of a collection agency, not exceeding, however, 50% of the amount unpaid thereon, together with such reasonable attorney fees as may be incurred in connection with the collection.

In addition, for value received, each and every person who signs this agreement or becomes liable thereon hereby waives presentment, demand, protest, and notice of non-payment hereof and binds himself as principle and not as surety and agrees to remain liable notwithstanding any time extension that may be made on the indebtedness. At the option of IRON MOUNTAIN QUARRY, the venue of any suit brought to collect this account may be held in Snohomish County, Washington.
